## NOTICE OF PUBLIC MEETING

(Under the Planning Act)

Stimulating Economic Growth: Proposed Community Improvement Plans for the City of Toronto,  
the Waterfront and the South of Eastern Employment District

### PROPOSAL

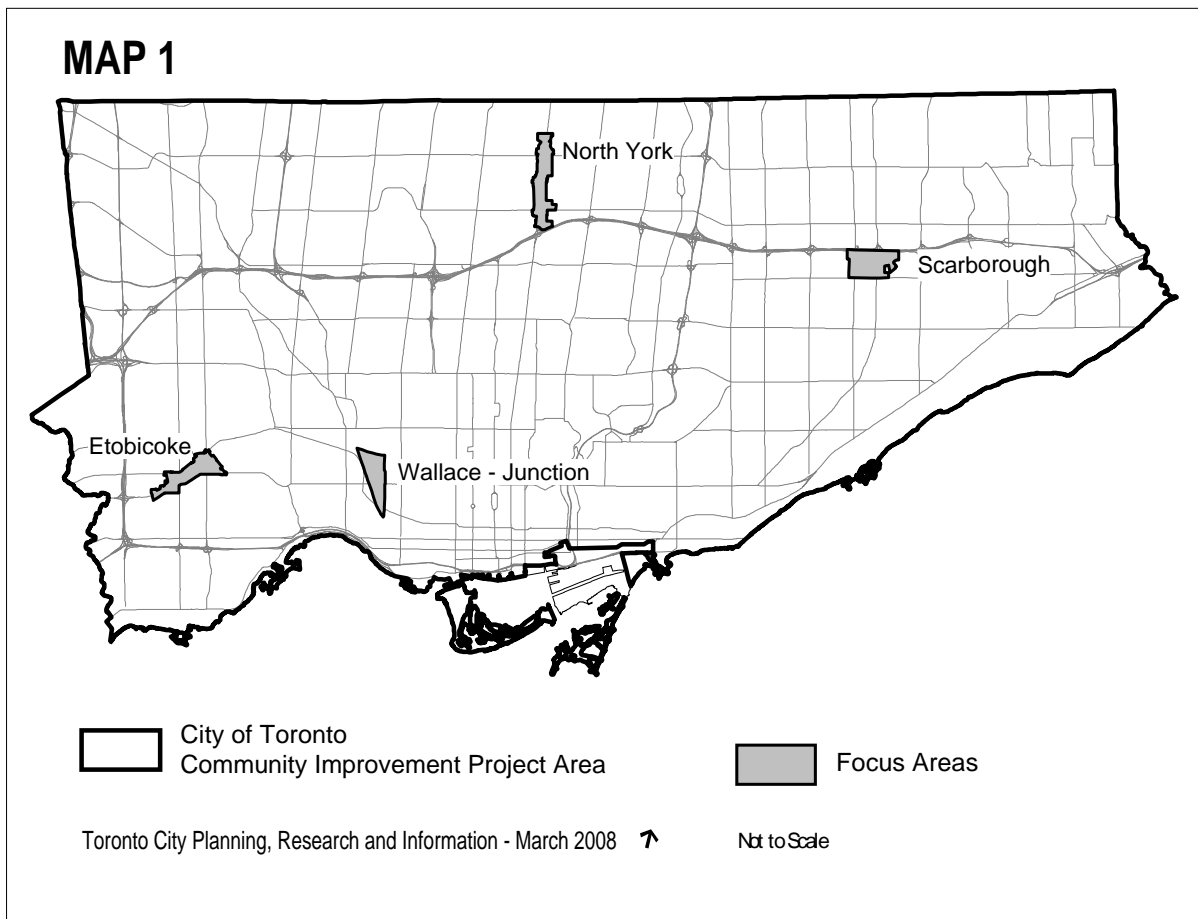
The City of Toronto proposes to adopt three Community Improvement Plans that offer financial incentives to support brownfield remediation and economic development across the City, excluding certain lands in the Waterfront.

The following financial incentives are proposed:

1. *Tax assistance for brownfields remediation.* The City is proposing to cancel any municipal tax increases on a property from the time remediation begins until two years after the property is redeveloped following its remediation, or three years if the property receives Development Grants (described below). School taxes may also be cancelled, if the Province chooses to participate in the program. These incentives will be available to properties that are redeveloped for employment uses, except retailing.
2. *Development Grants, also known as Tax Increment Equivalent Grants (or TIEGs).* The grant will be based on the increase in property taxes that results from new development or building expansion. The City is proposing to provide grants to a maximum of 60% of the total tax increment over ten years following the development or expansion. These grants would be in addition to any tax relief for brownfields remediation.

Three Community Improvement Plans (CIPs) are proposed, in order to recognize different conditions and circumstances relating to the provision of the incentives. Each CIP proposes to offer tax assistance for brownfields remediation (see above) and provide development grants, as follows:

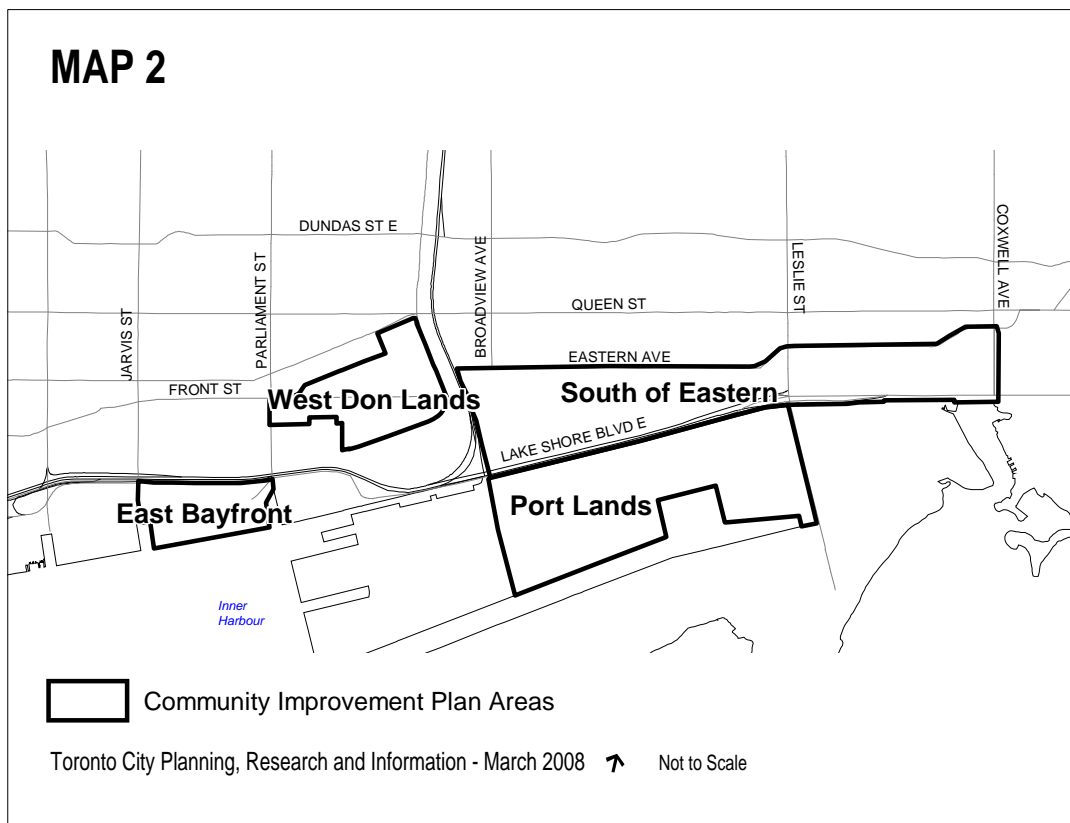
1. *The 'City-wide' CIP* will apply to the whole City, except the Waterfront and South of Eastern Employment District. This CIP proposes to provide development grants to:
  - o Targeted Sectors: Manufacturing, Information and Communications Technology (ICT), Biomedical, Creative Industries (except Film Studios, for which incentives are proposed only in selected areas of the City), Tourism Attractions;
  - o 'Convergence centres' and 'Incubators' for the targeted Sectors;
  - o Office buildings, if a significant portion of the space in the building is occupied by a 'corporate' office of one of the targeted Sectors, or without restriction on the occupants in the Etobicoke, North York and Scarborough Focus Areas (see Map 1);
  - o Transformative projects, subject to approval by the City Council



- Film Studios in the Wallace-Junction Focus Area (see Map 1).
2. *The Waterfront CIP* (see Map 2). This CIP proposes to provide development grants in three areas of the Waterfront, as follows (see Map 2):
    - East Bayfront and West Don Lands: see the list of the Sectors targeted in the City-wide CIP, above (except manufacturing), 'Convergence Centres' for targeted Sectors, 'Incubators', Colleges, and Office Buildings without restriction on occupants;
    - Port Lands: Film studios and related uses, the Sectors targeted in the City-wide CIP, 'Convergence Centres' for targeted Sectors, and 'Incubators'.
  3. *South of Eastern Employment District CIP* (see Map 2). This CIP proposes to provide development grants for Film Studios, the Sectors targeted in the City-wide CIP, 'Convergence Centres' for targeted Sectors, 'Incubators', and Office Buildings without restriction on occupants.

The Waterfront and South of Eastern CIPs also propose that the City may acquire land, develop it, rehabilitate or expand buildings on it, and dispose of the land or buildings at or below market value to implement the objectives of the CIPs.

The CIPs will contain details on program eligibility and administration.
